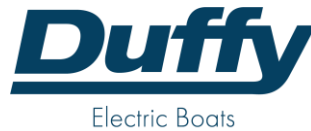

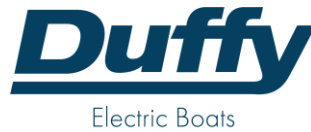

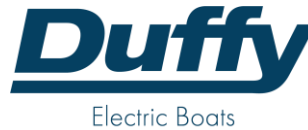

Duffield Marine, Inc. provides each new boat with a warranty registration card which must be filled out and sent to Duffield Marine, Inc. promptly after purchase; to help us fulfill our service obligations to our customers, and our legal obligation under the Federal Boat Safety Act. **Failure to complete and return the warranty registration card within 30 days of delivery of your boat will void your**

1. Duffield Marine, Inc. warrants each Duffy Electric Boat hull and liner manufactured by Duffield Marine, Inc. to be free from structural defects due to substandard material and workmanship, under conditions of normal consumer use and service for a period of 5 years from date of manufacture.
2. Duffield Marine, Inc. warrants each Duffy Electric Boat hull and liner manufactured by Duffield Marine, Inc. to be free from cosmetic defects (including bottom blistering) due to substandard material and/or workmanship, under conditions of normal consumer use and service for a period of 1 year from date of delivery to the original purchaser.
3. All enclosed models are built to resist water intrusion; however, during heavy prolonged rainstorms, leaking may occur.
4. Duffield Marine, Inc. warrants the electric motor, Infa-speed controller and Infa-speed actuator from defect under normal consumer use for the applicable time-period stated earlier, from date of delivery to the original purchaser. **This warranty is void if the motor, controller or actuator are subjected to excessive moisture or submerged partially or fully in fresh or salt water, no matter what the cause of such water exposure. Additionally, all applicable warranties are, to the maximum extent permitted by relevant laws, subject to the following terms and conditions:**
 - a. None of the foregoing warranties applies to any Duffy Electric Boat which has been structurally altered, subjected to unreasonable use, negligence or accident.
 - b. Items not manufactured by Duffield Marine, Inc. will be warranted to their full extent by the respective manufacturer's warranty. Warranty claims for such items will be processed through Duffield Marine, Inc. or the equipment manufacturer as determined by Duffield Marine, Inc.
 - c. The obligation of Duffield Marine, Inc. under these warranties is limited to the repair, replacement or making reimbursement within a reasonable time for such boat or part(s) which shall, within the warranty period, be determined to have been defective in material or workmanship. The decision to repair or make reimbursement for a particular boat or



part(s) shall be at the sole discretion of Duffy Marine, Inc. Replacement or reimbursement for such boat or part(s) will be prorated for use according to the portion of the warranty period elapsed when the claim is made.

- c. (continued)** For example, if you have had your boat for 3 years and a structural defect appears, you would be entitled at Duffy Marine Inc.'s election and assuming Duffy Marine, Inc. has not elected to repair, to reimbursement equal to 40% of your hull's purchase price or an equal credit toward the purchase price of a new hull. Duffy Marine, Inc. may require such boat or part(s) to be returned to an authorized dealer or its factory for an examination. Transportation charged prepaid. Duffy Marine, Inc. will reimburse these charges upon disclosure of a bonafide warranty claim.
- Duffy Marine, Inc. makes no other expressed warranties, and intends no implied warranties. If any implied warranties are found to exist, such implied warranties will be subject to the time limits appearing in continuing warranty documents. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. To the maximum extent permitted by applicable law, Duffy Marine, Inc. will not be liable for consequential damages of any kind resulting from a breach of any warranty, whether expressed or implied. Some states do not allow for the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.**
- d.** Duffy Marine, Inc. reserves the right to improve its products through changes in design or material without any obligation to incorporate such changes on boats of prior manufacture.
- e.** To initiate a warranty claim, it is the responsibility of the purchaser to contact an authorized Duffy Marine, Inc. dealer or the customer service department at Duffy Marine, Inc. (17130 Muskrat Ave Unit D, Adelanto, CA 92301) within a reasonable time after discovery of the defect, and to provide Duffy Marine, Inc. all appropriate details as to the nature of the problem, hull serial number (Hull ID), date of purchase and from whom, circumstances of the defect, and then to deliver to such dealer the boat with respect to which the warranty claim is made.
- f.** This warranty is limited to the original purchaser and is not transferrable to future owners of the boat.
- g.** This warranty gives you specific legal rights and you may also have other rights which vary from state to state.
- h.** Any "Duffy" electric boat used in commercial operations i.e. rental, tour boat, water taxi, etc., alters the standard limited warranty issued for the product line and the commercial warranty applies.
